

Deck Officer Admits Error Over Course

 June 3. They were read into the record of a six-man U.S. Australian board investigating the crash which killed 74 U.S. sailors.

 Panel Changes Mind
 The panel previously had made shortly after the collision

statements but today changed its mind. No explanation was given.
 In the testimony, Ramsey made these points:
 —He believed the carrier was changing its course from 230 degrees to 160 degrees—a sweeping left turn—after ordering the Evans to change its position to 1,000 yards astern of the carrier.
 —As the two ships moved on a collision course and began closing in on each other at 38 knots, Ramsey realized the carrier actually had not changed its course. He then ordered a hard right turn, which he believed would have avoided the collision had not the Melbourne also turned at the last minute.
 Ramsey said at about 3:10

a.m., the Melbourne ordered the Evans to take up its new position. He said he then heard a radio message from the Melbourne saying "My course or corpen is 160." The officer said he believed this to mean the carrier was changing course to 160 degrees.
 In Navy terminology, Corpen means "changing to."
 On Collision Course
 Ramsey said he told Hopson to watch the carrier closely because it did not appear to be following its new course. The two ships began to close and the Melbourne messaged "You are on a collision course," he impact, the Evans turning right and the Melbourne turning left.
 "I didn't understand...I yelled right full rudder," Ramsey said.
 At this point, he said, he still

believed the collision could have been avoided. But then he heard the carrier signal "My rudder is hard left."
 "I heard a tremendous roar and I was swept into the water. I kept clawing away from the ship," Ramsey said. Both Hopson and Ramsey were rescued by Melbourne crew members.
 Previous testimony had said there was some confusion on the part of Evans crew members about the Melbourne's course. It also indicated the two ships had turned into each other just before the impact, the Evans turning right and the Melbourne turning left.

Road Uses 16 Gallons Of Paint Per Mile

ALBANY, N.Y. (UPI)—New York State uses enough yellow and white paint for highway safety markings annually to paint a six-inch stripe around the world at the equator. Put another way: enough to paint 110,000 average-sized houses.
 Those statistics are contained in a highway safety report issued by Governor Rockefeller's office today.
 The governor said the State Transportation Department will use more than a half million gallons of paint this year to paint 21,050 miles of white line and 14,080 miles of yellow line at the rate of 16 gallons per mile.
 To make the paint reflective, the department will use 3,372,480 pounds of glass beads, which are dispensed from the pavement marking machine at the rate of six pounds per gallon. The beads—about the texture of table salt—are applied to the pavement markings a split second after the paint.

Bonny's Death

HONOLULU, Hawaii (UPI)—It may take months to determine what caused the death of America's space monkey three weeks before the end of his scheduled 30-day mission, according to an official of the National Aeronautics and Space Administration.
 "There was no specific evidence of the heart or brain malfunction which can point to the problem now."
 He said an extensive autopsy would be performed on the monkey at Hickam AFB, but the results probably would not be known for months.
 Adey noted Bonny's body temperature was lower than normal on the ninth day of the planned month-long flight, but "that was the only indication, the primate was not adapting."

ALBANY, N.Y. (AP) A temporary state commission to study student unrest on college campuses was completed Monday with the appointment of the last three members by Gov. Rockefeller.
 Those appointed were Carl H. Pforzheimer Jr. of Purchase, Westchester County, a member of the State Board of Regents; Edward F. Carpenter, headmaster of the Harlem Preparatory School, New York City; and Edward F. Regan of Buffalo, a lawyer and Republican city councilman at large.
 The nine-member commission was authorized by the 1969 legislature. Six other members were appointed last month by Assembly Speaker Perry B. Duryea Jr. and Senate Majority Leader Earl W. Brydges.

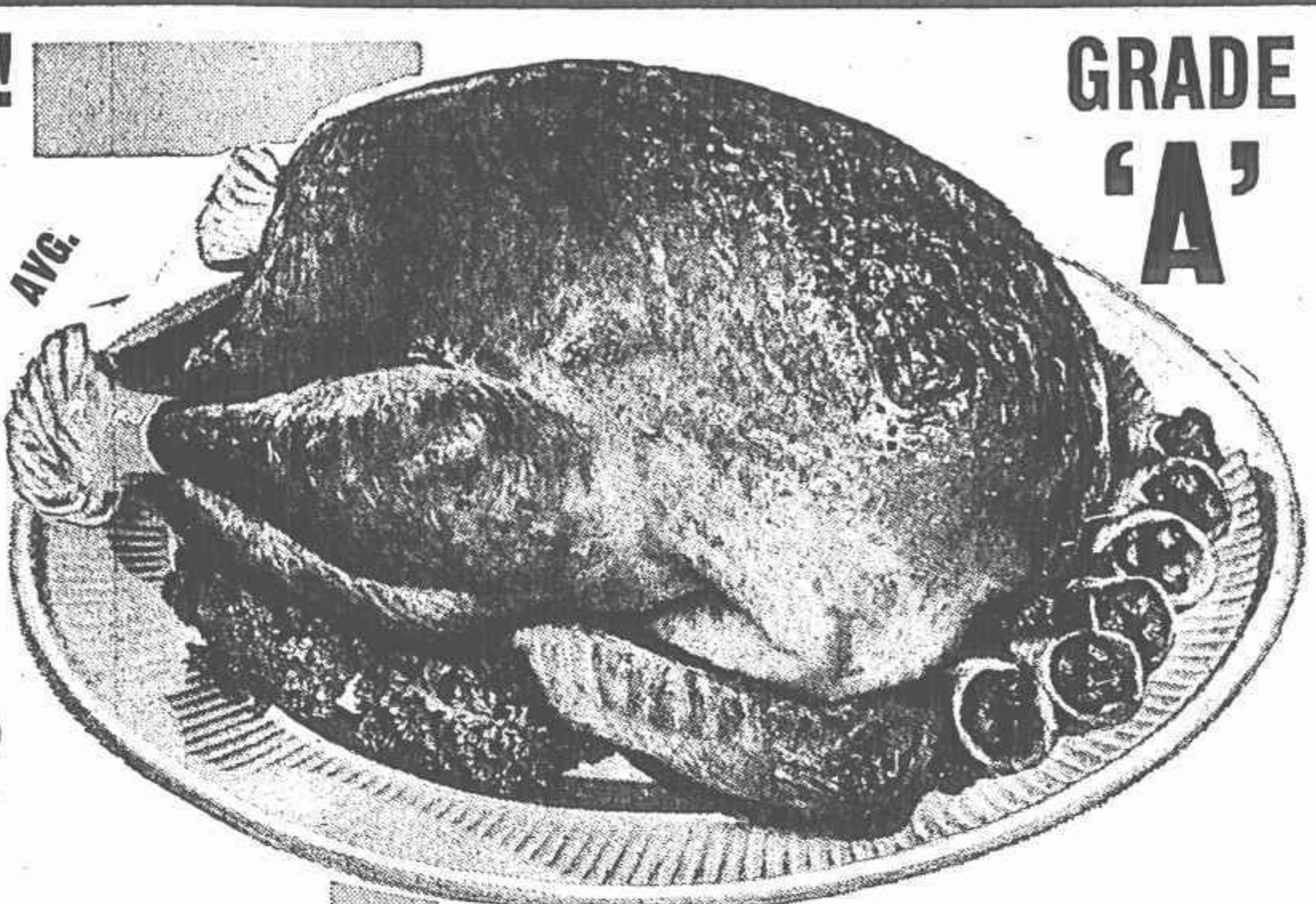
